**ISSUE OF MINDAX LIMITED SHARES – SECONDARY TRADING NOTICE NOTIFICATION
PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 (Act)**

On 12 August 2019 Mindax Limited (**Company**) issued 10,000,000 fully paid ordinary shares at an issue price of \$0.005 per share (**Securities**).

Secondary Trading Exemption
