## **EXPLORATION UPDATE**

## **Lake Noondie Uranium Project**

Mindax has received permission from the Minister of Indigenous Affairs to proceed with work on the Lake Noondie project southeast of Sandstone. This approval was necessary because the project area impacts on a registered aboriginal site.

The Lake Noondie Project is a new palaeochannel uranium target identified from airborne radiometrics early in 2005 where the Lake Noondie drainage pinches through the Maynard Hills greenstone belt. The target has a radiometric footprint of some 20 km, nearly twice that of Yeelirrie. Sampling of surface lake sediments over the central part of the anomaly has returned anomalous values up to 60 ppm U. The target is uranium mineralisation in calcretes and sands at and below the water table.

Mindax have planned an initial shallow air-core drilling program to test an area of 4 x 1.5 km and will now move towards executing that program.

Mindax is also looking for uranium in the South East of Western Australia through the Avon Joint Venture area with Quasar Resources (an affiliate of Heathgate Resources). This program includes a collaborative research project on uranium-in-water with the CRC LEME. This is part of a wider private-public research initiative on drylands salinity. The project has already generated very significant uranium anomalism in ground waters to >1000 ppb U and indicates a new uranium province. The joint venture has applications for 11 exploration licences in the area.

Overall Mindax have a uranium tenement portfolio totalling 2,400 km2.
